Subject: - Grant of permission to run/establish of a private educational institution.

Sir,

On the careful consideration of the inspection report submitted by the Inspection Committee vide letter No.-EDN-MND(G-4)Pvt. School-88916 dated 05-03-2016 constituted for the purpose of inspection of Private Educational Institutions of the School level for grant of permission to run/establish a private educational institution by the Govt. of H.P. Shimla vide Notification No.-Shiksha-II-Chha(11)-2/2005-L dated 03-05-2006 and in exercise of the powers vested in me vide Govt. Notification No. Shiksha-II-Chha 5P-3/97 dated 16-01-2007, the approval of competent authority with regard to issue of Permission for establishment/running/up gradation of private Educational Institution in respect of "MAA KAMAKSHA SHIKSHA SANSTHAN SUNDERNAGAR (HP)" registered under (As per the provisions of Registration Act) Registration No. 1683/2013 on dated 23-11-2013 for the establishment of "Pine Grove School Dodhwan, P.O. Bhojpur, Tehsil Sunder Nagar, District Mandi, H.P" for 9<sup>th</sup> to 10<sup>th</sup> classes from the academic session 2016-17 (if the affiliating Board find fit) is conveyed subject to the following terms and conditions:-

1. That the school concerned shall be affiliated to H.P. Board of School, Education Dharamshala for 9<sup>th</sup> to 10<sup>th</sup> classes.
2. That the State Govt. will not provide any type of financial assistance/Grant-in-aid etc. in respect of the said institution.
3. That the admission in the institution shall be made strictly in accordance with the norms as lay down by the Board of School Education to which the school is affiliated and no discrimination on the basis of caste, colour, creed and sex shall be made. No pupil shall be refused admission on account of his caste, creed or religion.
4. That the private institution shall employ only the trained/eligible staff as per the norms fixed by the Govt.
5. That no particular religious education shall be imparted by the institution to maintain secular character of the institution.
6. That the fees and funds shall be such that they are not of exploiting nature but contribute to the spread of education. They should be commensurate to the salary of the staff being paid, development of infrastructure and facilities and activities being provided to the students. (Donation in any form from the student is strictly prohibited).
7. That the permission to run or establish a private educational institution shall be granted only on individual basis and the institution shall not be entitled to open its branches elsewhere.
8. That the institution shall maintain proper record accounts and register in accordance with norms of HP Govt. As stated in chapter III of the Himachal Pradesh Private Educational
